*Please sign the bottom of this document stating that you have read and understand.*

1. The Rebuilding Together Yard Sale takes place on Saturday, October 3, 2009, from 8:00 AM to 2:00 PM, at St. Luke's United Methodist Church; 5<sup>th</sup> & Franklin Sts; Denton, MD and will be held rain or shine.
2. Table / registration fee, indicated on the front of this form, are available while supplies last.
3. Reservations for exact table location are upon receipt of payment.
4. Payment of table space is a commitment for participation.
5. Refunds will not be offered once a space is confirmed, even if we experience inclement weather.
6. For inside tables, a table and chair is provided. No additional tables for set-up may be used.
7. All table reservations will be given a parking permit that must be displayed in your vehicle's front windshield.
8. Vendor vehicles not having a parking permit are to be parked on the street after unloading & prior to 7:45 AM.
9. No overnight parking.
10. Set-up begins at 7:00 AM and must be completed no later than 7:45 AM. Tables will be assigned & marked by reservation. Tables may not be moved from their original location.
11. All merchandise must be kept within your table. No set-up will be allowed to the sides of your table. Please adhere to these restrictions due to space limitations.
12. Clothing is allowed; however, only one clothing rack is only allowed per *outside* space reservation.
13. No concession (food/beverage items) are allowed.
14. Clean up begins promptly at 1:30 PM and must be complete by 2:00 PM.
15. Kindly pick up around your space following the completion of the event. Do not leave behind any trash or merchandise after the sale. Any items left in your space will be donated.
16. The following items are not accepted at this sale: merchandise that is not authentic, political or religious handouts, pornographic or nude material, and anything viewed by Rebuilding Together that is not deemed acceptable to a family audience.
17. Tents or umbrellas are prohibited during the sale, even in the event of inclement weather.
18. If you are unable to follow the above guidelines, you will be asked to leave the event. Your table rental fee and deposit will not be refunded and will result in your inability to participate in future sales.
